The new ASCR bracket support enables gutter brackets to be quickly clipped to a Belriv® System fascia board. It has been specifically designed with fascia brackets in mind.

Advantages :

- Enables gutter to be clipped to a Belriv® System fascia board
- 134 mm support longer than a traditional ASC (94 mm)
- Recommended for attaching fascia brackets
- Automatic adjustment of gutter slope
- Bevelled top section to accommodate flat tiles
- Colours : white, sand, black, grey and brown

The new ASCR bracket support is the perfect complement to the ASC support. It is longer and adapted to fascia brackets which have larger base plates. Therefore, on a Belriv® System fascia board, an ASCR support is the recommended method for attaching a semicircular LG25 gutter using a fascia bracket.

The bevelled head of the ASCR is another plus when installing under flat roofing (flat tiles, etc.) as it avoids lifting the tile.

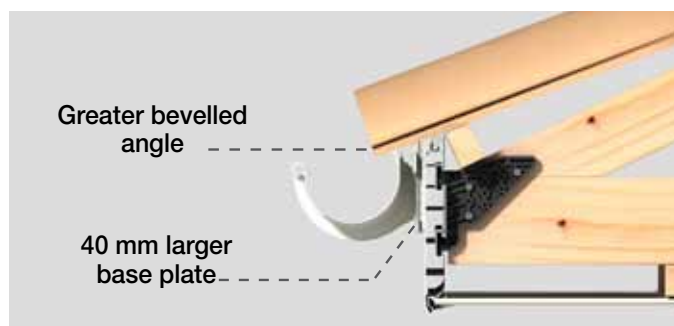

INSTALLATION

The ASCR is installed in the same way as the ASC :

- Screw the gutter bracket to the ASCR support while adjusting the slope using the pre-drilled holes.
- Clip the support to the Belriv System fascia board.
